#### Method of recruitment :-

A structured interview is used for selection of posts 01 to 04 and 07 while posts 05 and 06 are followed by written competitive examination and structured interview.

#### Nature of the appointment :-

This is a permanent appointment and the selected officer is entitled to the benefits of Employees' Provident Fund and Employees' Trust Fund.

#### Every candidate :-

- Should be a citizen of Sri Lanka
- Should be not less than 18 years and not more than 45 years of age.
- Should have the mental and physical fitness to perform the duties entrusted to the post properly.
- Should be a permanent resident of the Western Province. Further, the applicant should prove the residence within Western Province for a period of 03 years as at the closing date of application.
- Should be of excellent moral character

#### Method of applications :-

- Applications should be sent by registered post along with the copies of relevant certificates to reach before **26.04.2024** and the post applied for should be written on the top left-corner of the envelope which contains the application. Applications which are sent without photocopies of relevant educational /professional qualifications will be rejected without any notice.

Applicants, who are already serving in Government Departments, Statutory Boards or State Corporations, should submit their applications through the respective Heads of Institutions. In the meantime the Head of Institution should have certified that the applicant will be released from the service within a month, if he/she is selected to the post.

- When the applicants, who apply under all above, have satisfied the required qualifications from an institution other than a National University (Local / Foreign), a letter issued by the University Grants Commission to the effect that such institution has been recognized by the U.G.U. should be submitted.

- Further, the applicants who apply with similar qualifications above should submit a letter issued by the TVEC to prove the possessed qualifications are equivalent to the NVQ Levels.
