PROJECT MANAGEMENT SPECIALIST (PRIVATE SECTOR ENGAGEMENT)

The United States Agency for International Development (USAID) in Colombo seeks suitable candidates for the position as Project Management Specialist (Private Sector Engagement (PSE) – FSN 11), to serve the Office for Economic Growth - Sri Lanka and Maldives.

The USAID Project Management Specialist is the Mission's technical expert on environment, climate change and private sector engagement and climate finance for Sri Lanka and Maldives and focal point for private sector engagement (PSE). USAID/Sri Lanka & Maldives' Economic Growth program covers a broad range of related activities that support climate change adaptation, reducing ocean plastic waste, renewable energy, private sector competitiveness, business enabling environment, SME (Small and Medium Enterprises) development, public financial management, trade facilitation, agriculture modernization, tourism development and workforce development. Under the supervision of the Deputy Director of the Office for Economic Growth, the Project Management Specialist is primarily responsible for advancing and integrating private sector engagement in economic growth-related activities. S/he must have experience and knowledge related to environmental and economic policy and the roles that government and the private sector play in climate change adaptation, waste management, and in promoting inclusive economic growth. The USAID Project Management Specialist is expected to provide leadership relating to these aspects of economic development and keep abreast of social and economic conditions in Sri Lanka and Maldives, as well as environment and economic trends and their impact on each country's respective economy. The USAID Project Management Specialist analyzes factors in promoting environmental and climate resilience, constraints and issues affecting sustainable economic growth, and prepares reports, provides guidance, and develops and monitors projects undertaken with USAID support. S/he also establishes and maintains policy dialogue with government, private sector, donors and international organizations. This includes evaluating the status of current national environmental and economic policies and providing advice on their implications on programming.

Remuneration for this position will be between USD 19,974 to USD 33,953 per annum (plus allowances as per the Mission Compensation Plan)
