01. POST OF OCCUPATIONAL THERAPIST

Qualifications : Criteria I :

- A. Obtained a degree recognized by the UCG in Occupational Therapy And,
- B. Successful completion of six (6) months orientation and co-ordination course conducted by the Ministry of Health.

Note : In the case of foreign university degree holders, they should have registered with the Medical Council of Sri Lanka to practice as occupational therapist.

OR

Criteria II :

- A. Having passed the G.C.E. (O/L) examination in six (6) subjects in one (1) or two (2) sittings with credit passes for Sinhala or Tamil language, English language, Science and Mathematics.
And,
- B. Having passed three (3) subjects (other than the General paper) at the G.C.E. (A/L) examination with credit pass for Physics and two (2) other subjects which should include Combined Mathematics, Chemistry, Biology or Agriculture.
And,
- C. Successful completion of two (2) years full time (Internal) Diploma course on Occupational Therapy conducted by the Ministry of Health.

Age : Applicants should be not more than 50 years of age.
