## G.C.E. (O/L) Examination - 2024(2025)

It is hereby notified that the G.C.E. (O/L) Examination 2024(2025) is scheduled to be held from 17th March to 26th March 2025.

Admission cards of school candidates of this examination have already been posted to the heads of respective schools and to the addresses of private candidates as provided in their applications. It is hereby notified that the admission cards sent to the heads of schools **should be handed over to relevant candidates immediately** and should not be delayed for any reason.

Facilities to download admission cards by accessing the official website of the department **www.doenets.lk** will be provided from 07.03.2025 for private candidates who have not received admission cards so far by post.

Any private applicant who has not yet received admission card or could not download the admission card so far should visit the Department of Examinations in person with a photocopy of the application, a photocopy of the receipt for payment of examination fee or a certified letter obtained from the Postmaster confirming the payments of examination fee.

**Any changes to be made in the subject, medium or name cited** in the admission cards received by Principals or private candidates,

- **Should be revised online by accessing the website <http://onlineexams.gov.lk/eic>.**
- **Only one attempt of revision will be given to each candidate.**
- **Examination centres in this examination will not be changed.**
- **The duration offered for changes will be concluded at 12.00 midnight on 10.03.2025.**

The National Identity Card issued by the Department for Registration of Persons, a valid Passport or a valid Driving License will be accepted as a valid document to prove identity of a candidate at this examination.

01. Impersonation in the examination, keeping notes in possession while answering, getting assistance from or assisting another candidate, or misbehaving in and around the examination hall shall be a punishable offence under the Examinations Act.
02. Using calculators and correction fluid in this examination is not permitted.
03. Sitting for this examination as a private candidate while studying in a government school shall be a punishable offence.
04. Bringing Mobile Phones, Smart Watches or Electronic Devices into the examination hall, keeping in possession and using such devices are strictly prohibited. Any candidate who violates this condition will be subject to a five year examination ban and the relevant devices may be confiscated.
05. All candidates should keep their faces and ears opened so as to clearly visible during the examination in order to be affirmed that the candidates are not using Bluetooth or any other electronic communication devices. Legal actions will be taken against the candidates who violate these examination rules.
