### 02. Director (Finance) - 01 post

**1.**A degree in Management / Commerce / Accountancy or Business Administration obtained from a university recognized by the University Grants Commission and post graduate degree in a related field with Associate Membership of a recognized chartered professional body.

And

Minimum 13 years of experience in the relevant field in a managerial level position in a Government, State Corporation, Board, Statutory body or a recognized private institution after graduation.

**2.**Full membership of a recognized chartered professional body in the subject area relevant to the post.

And

Minimum 13 years of experience in the relevant field in a managerial level position in a Government, State Corporation, Board, Statutory body or a recognized private institution after graduation.

### 04. . Engineer (Information Technology) - 01 post

An engineering Degree in Information Technology obtained from a university recognized by the University Grants Commission and Associate membership of the Sri Lanka Institute of Engineering.

(This age limit does not apply to individuals currently employed in the public sector, including government departments, corporations, boards, and statutory bodies. )
- Salary: MM 1-1 Rs. 91,690-168,240 (2,480 X10-3,450 X15)  
(Salary will be paid as per Management Service Circular 01/2025.)

### 05. Engineer (Engineer - Communication). 01 Post

- Qualifications and Experience Required:

An Engineering Degree in Electronics and Telecommunication obtained from a university recognized by the University Grants Commission

And

Associate membership of the Sri Lanka Institute of Engineering.

### 06. Orchestra Leader - 01 post

- Qualifications and Experience Required:

A degree in Music obtained from a university recognized by the University Grants Commission

(This age limit does not apply to individuals currently employed in the public sector, including government departments, corporations, boards, and statutory bodies.)
- Salary :JM 1-1 Rs 72,650-122,970(1,360 X10-2,040 X18)  
(Salary will be paid as per Management Service Circular 01/2025.)
