## Part 1

## **General Information**

## 1.0 The Open University of Sri Lanka

The Open University of Sri Lanka (OUSL), which was established in 1980, is a national university constituted under the University Act No. 16 of 1978 and the OUSL Ordinance No. 1 of 1990 and has the same legal and academic status as any other national university in Sri Lanka. It is the pioneer University in Sri Lanka that offered further education through distance mode.

The academic programmes of the Open University have been designed to enable persons aged 18 and over to pursue courses leading to Certificates, Diplomas, Degrees and Post Graduate qualifications in their own time and in their own homes.

The Open University comprises of a central Campus, which is located in Nawala, Nugegoda, nine Regional Centres (Colombo, Kandy, Matara, Baticaloa, Anuradhapura, Badulla, Kurunegala, Rathnapura and Jaffna), and several study centres located throughout the Island.

Currently, the Open University consists of six faculties namely Faculty of Humanities and Social Sciences, Faculty of Natural Sciences, Faculty of Engineering Technology, Faculty of Education, and Faculty of Health Sciences and Faculty of Management Studies. The Master of Teacher Education (International) Degree Programme, for which the details are given in Part II of this brochure, is one of the programmes offered by the Department of Secondary & Tertiary Education of the Faculty of Education.

## 1.1 Courses and Programmes

In the Open University vocabulary, a **course** is a **unit of study**, which is generally completed within an academic year. A course can either be compulsory or optional.

A **programme of study** consists of a combination of compulsory and optional courses. To meet the criteria for an award of a certificate, a diploma, or a degree it is necessary to complete a programme of study successfully.

The programmes of study offered by the Open University are as follows:

- 1. Foundation Programmes
- 2. Certificate Programmes
- 3. Higher Certificate Programmes
- 4. Diploma Programmes
- 5. Bachelor's Degree Programmes
- 6. Post Graduate Diploma Programmes
- 7. Postgraduate Degree Programmes
- 8. Continuing Education Programmes
- 9. Stand Alone Courses

Foundation Programmes provide opportunities to enrol for Degree Programmes. These Programmes are offered in two levels namely Level 1 and Level 2. A student who completes any Foundation Programme in Arts, Commerce, Physical Sciences, Biological Sciences, or Technological Sciences attains qualifications similar to the level required to enter a conventional University.

Stand-alone Programmes are not linked to any key Programmes. These can be followed according to the individual needs of any person.

The academic value of a **Course** is expressed in terms of **Credit** rating. It does not mean a student's performance in an examination. (E.g. A Credit Pass at G. C. E. Ordinary Level or Advanced Level).

A credit is calculated on the basis of the number of hours a student has to spend in learning. One credit is considered equivalent to **50 Notional Learning Hours (NLH)** for a taught course. The maximum number of credits a student is permitted to register for an academic year is thirtyeight (38) including continuing education course. The minimum number of credits a student can register for an academic year is eight (8). Students who have enrolled for 30 credits may **Courses** designated as Continuing Education up to a limit of further eight (8) credits.

Each course is assigned a course code consisting of seven (7) alphanumeric characters as follows:

## 1.2 Teaching Systems

Teaching system of the Open University is based on multimedia.

## i. Printed Material

The central element in the teaching system is a series of printed course material that fulfils several purposes. They provide the student with the primary material for study and offers the equivalent of lectures that help the student to learn. It also provides a series of carefully designed self-assessment questions (SAQ) interspersed through the text. These will also help the student to develop analytical skills and independent thought.

## ii. Audio-Visual Aids

These are particularly important for the self-learner. 'They are designed to supplement the printed material and enable contact between students and teachers.

## iii. Face to Face Session (Day Schools)

Although the printed material and audio-visual aids are designed for students to learn independently, day schools are conducted from time to time -to discuss problems arising from the printed texts and assignments and to conduct practical work related to the courses of study.

• These day schools are conducted by permanent staff of the OUSL as well as visiting staff from other Universities, Institutes etc.

## iv. Library Facilities

In all regional and study centres there are library facilities. The library at Nawala is open for students from Monday to Sunday from 8.30 a.m. to 6.30 p.m. The library will be closed on the full moon Poya days and university special holidays. Students at level 3 and above could avail themselves of limited lending facilities on payment of a refundable deposit of Rs.1000/- for a Postgraduate degree.

## **1.3** Evaluation System

Student attainment is assessed by Assignments (Continuous Assessments) and Final Examination. Students are expected to complete the required number of assignments for each course. Evaluated assignments are returned to the students with comments and grades given by the marking examiners.

These assignments, which are considered to be a very important part of the assessment system of the OUSL, will differ from course to course. For example, presentations, learning portfolio, written assignments, Closed Book Test (CBT), Open Book Test (OBT), Revision Tests etc.

The detail of assignments in each course will be informed to the students at the beginning of each course.

After successful completion of Assessments, students could sit for the final examination.

The students who are **not** getting Overall Continuous Assessment Marks (OCAM) to sit the final examination will have to **re-register for the particular course**. Student those who fail the final examination should re-sit for the final examination. But they need not complete the assignments again.

## 1.4 Regional Services

Open University has established Regional / Study Centres Island wide to facilitate student learning and discussion with other students. A list of eight Regional and nineteen Study centres established by the OUSL up to now are given below.

## **PROGRAMME OF STUDY**

## 2.0 Master of Teacher Education Programme (MTE)

Welcome to the Master of Teacher Education programme.

We are delighted that you are considering joining this exciting programme of the Open University of Sri Lanka (OUSL).

The Master of Teacher Education (MTE) Programme has been developed by Department of Secondary & Tertiary Education of the Faculty of Education of the Open University of Sri Lanka, in partnership with the Commonwealth of Learning (COL), Canada.

#### 2.1 **Aim and Objectives**

The goal of the Master of Teacher Education programme is to develop among teacher educators' competencies and practices in relation to the following areas:

- 1. Teaching and learning strategies, including assessment of learning outcomes.
- 2. Design, development, and use of educational technologies in teaching and learning.
- 3. Design, development, and evaluation of curricular and curriculum related activities.
- 4. Management and leadership in teaching, learning and related educational activities.
- 5. Research and evaluation of teaching, learning and related educational activities, and
- 6. Teaching as a profession and the professional roles and responsibilities of teachers.

### 2.2 **The Target Group**

The target group for which the programme is particularly intended consists mainly of teacher educators, serving in institutions under the Ministry of Education and Faculties/ Departments of Education in Universities.

### 2.3 **Admission Requirements and Procedures**

The minimum requirement for admission to the Master of Teacher Education Degree Programme will be as follows.

## A person seeking admission to the programme leading to the award of the Degree of Master of Teacher Education shall be required to have:

- obtained a bachelor's degree in Education from a recognized University, or
- obtained a bachelor's degree and the Postgraduate Diploma in Education from a recognized University, or
- secured any equivalent or higher qualification acceptable to the Senate,

### and

- Should be serving at present as a
  - i. Academic staff member of a recognized University,

### Or

ii. An officer in the Sri Lanka Teacher Educator Service,

### Or

iii. Lecturer of a Teacher Training College, Or

iv. Officer engaged in Teacher Education in the National Institute of Education,

Or

- v. Principal of a Government/Government Approved school (Private/International) with a Principal Grade,
- vi. In-Service Advisor of a Teacher Professional Development Centre /Ministry of Education/ Provincial Ministry of Education,
- vii. An Officer in the Educational Administrative Service.
  - The programme is conducted in English, Sinhala, and Tamil media.
  - All applicants should have a good command in English, irrespective of the Medium.
  - Selection of candidates for the programme will be done either by a written test or an interview.

## 2.4 Registration and period of study

- 2.4.1 In order to be registered for the degree of Master of Teacher Education a student should satisfy the council with the admission requirements stated above (under section 2.3).
- 2.4.2 A student may acquire the credits required 38 Credits from Core Courses within a maximum of three (03) academic years from his/her initial registration to the Degree of Master of Teacher Education Programme, provided that he/she maintains his /her registration as a student or has his/her registration reactivated in accordance with section 4.9 of the General by Law.
- 2.4.3 Registration fees and course fees as stipulated under section 2.8 should be paid by the candidate. Normally a candidate is allowed to pay this amount in two instalments at the registration of the programme.
- 2.4.4 When applications are called for registration for the programme the prospective candidates may apply for the programme adhering to the instructions given therein.

## 2.5 **Programme Structure and Content**

Taking into account the needs of practicing teacher educators in the field, the MTE programme is very practice oriented in its pedagogical design.

A critical and unique feature of this degree programme is its use of authentic learning scenarios to situate the study activities in each course. These learning scenarios have been developed to reflect the kinds of situations that the students are very likely to confront as teacher educators.

The MTE programme comprises six Core Courses that are focused on the various roles of teacher educators rather than specific subject matter content areas. In adopting this approach, the courses in the new programme seek to make the learning of facts, principles and procedures a lot more meaningful. The new programme also incorporates the completion of a Learning Portfolio project, as opposed to a conventional thesis. Minimum duration of the programme is one academic year consisting of two semesters.

## **Programme Structure**

This is a Thirty-Eight (38) credit programme consisting of six Core Courses (each worth 5 credit), and Portfolio Project (worth 08 credits).

## Curriculum of the Master of Teacher Education

## **Learning Environment**

Online materials including a Study Guide with detailed study schedules, and a Resource Pack consisting of essential readings, additional readings, and multimedia resources, comprise the major forms of student support.

Contact sessions including day school and workshops will provide opportunities for closer interaction. In addition, local study centre support with library, audio-visual materials, computer, and internet facilities are provided.

## 2.6 Scheme of Assessment– Core Courses

In this programme, conventional methods of assessments of learning outcomes have been replaced by tasks and assessment procedures that can be focused on the processors of learning, perception and problem-solving.

There will be no final written examination in any of the Courses. The final assessment of a student in any Core Course shall be through Continuous Assessments, in the form of a given number of Mini Projects per course, all of which are compulsory. The total marks obtainable for the Mini Projects in a course is 100. The Overall Assessment Mark (OAM) for a Core Course will be the total of the Continuous Assessment Marks (CAM) obtained from all the Mini Projects.

A student shall have to score a minimum of 50% of marks allocated for each Mini Project in a Core Course in order to gain a pass in that Mini Project. In the compilation of the Overall Continuous Assessment Mark (OCAM) for a Core Course, only one "C-" (45-49) grade for a Mini Project shall be permitted. A student who fails to obtain 50% in a particular Core Course shall be deemed to have failed in that course. Such a student may repeat that course by reregistering subject. A student who completes the requirements of the final assessment of any Core Course of the Master of Teacher Education Programme offered by the Faculty of Education should be awarded a Grade and a Grade Point Value based on the overall assessment mark (Z%) as follows:

## A+, A, A-, B+, B, B-, C+, C constitute pass grades.

A student who is awarded a C-, D+, D or E grade cannot count that Core Course towards his/her credit requirements unless he/she resubmits the Mini Projects on a subsequent occasion and obtains a C grade. A student who repeats a Core Course shall be deemed to have obtained a mark which is not higher than 50% and a grade not higher than C.

## 2.7.1 Medium of Instruction

This programme of study is available in English, Sinhala, and Tamil media.

Some of the printed course material would be made available in English, and some in Sinhala or Tamil. Students are required to submit written work needed for learning assessment in student's own language or else as typed documents.

## 2.7.2 Award of the Master of Teacher Education Degree

A student who obtains a minimum C pass in all courses will be deemed to have passed and will be awarded the Master of Teacher Education Degree

## *Postponement of the programme/courses*

You are not allowed to postpone the whole programme of study. The period during which you are allowed to postpone the courses for which you are registered ends in three (3) months from the date of registration. This date would not be extended for whatever reason. However, you are required to keep registration for courses to the value of 8 credits.

## Withdrawal from the programme

You are allowed to withdraw from the programme, you are registered for, within one month of the date of registration, subject to a 10% fee. This date would not be extended for whatever reason. Registration and re-registration will not be conducted after the dates informed by the university.
