3. Review valuations involving leasehold and condominium properties.
4. Evaluation of the suitability of the applicants to be appointed to the Bank's Panel of Valuers.
5. Review valuations pertaining to properties to be acquired/sold by the Bank.
6. Review Rental Valuations of Buildings to be rented out by the Bank.
7. Review revaluation of bank assets and to carry out other related services of Valuation Review Panel

Acquired Continuous Professional Development (CPD) as approved by the Professional Body. (Preference will be given for the Valuers who work as BOC Panel B Valuers)
