Qualification Guidelines

No.	Posts	Qualifications
1.	Director/ Physical Education	(As per UGC Commission Circular No. 18/2018) 1. Should possess a degree in Physical Education from a recognized University/ HEI or equivalent with at least ten (10) years of experience in organizing and implementing the physical educational programmes after obtaining such degree. OR 2. Should possess a degree from a recognized University/ HEI with a postgraduate qualification in Physical Education or professional qualification in the relevant field with at least twelve (12) years of experience in organizing and implementing physical educational programmes in reputed institutes after obtaining the first degree. OR 3. A holder of the post of Assistant Director/ Physical Education in the University system and confirmed in that post with not less than five (05) years of service in that grade.
2.	Assistant Registrar (Legal & Documentation)	(As per UGC Commission Circular No.948) 1. An Attorney-at-Law with A Degree in Law/ Legal Studies with not less than two (02) years of experience gained in Court work, legal work and drafting legal documentation in a State/ Corporation or reputed private sector organization or official bar after obtaining the above qualification. OR 2. An Attorney-at-Law with not less than three (03) years of experience gained in Court work, Legal work and drafting legal documentation in a State/ Corporation or reputed private sector organization or official bar after obtaining the above qualification.
3.	Management Assistant Gr. III	(As per UGC Commission Circular No. 06/2018 and 06/2018[ii]) 1. Should have passed the G.C.E. (O/L) Examination in six (06) subjects at one sitting with credit passes in:- i. Sinhala Language/ Tamil Language ii. English Language/ English Literature iii. Mathematics AND

		2. Should have passed in all subjects at <i>G.C.E (A/L)</i> examination (except the Common General Paper) at one sitting. (Passing in 03 subjects under the old syllabus at one sitting would be sufficient for this purpose.) 3. Preference will be given to those who possess the following; a) An acceptable qualification in computer applications of not less than six (06) months duration obtained from a recognized institute. AND b) Two years of experience in the use of computer application packages. Note: Eligibility a) Should be a citizen of Sri Lanka. b) Should be not less than 18 years and not more than 30 years of age on the closing date of applications. c) Should be of good character
4.	Nursing Officer (on Contract)	(As per UGC Commission Circular No. 424) 1. <i>G.C.E (O/L)</i> Examination in six subjects at not more than two sittings with credit passes in 03 subjects. 2. Certificate of competence as a Nurse recognized by the Sri Lanka Medical Council. Age not more than 40 years on the closing date of applications. Common Facts: Appointment will be made initially for a period of six months and extendable for further period.
