North Central Provincial Public Service-North Central Province **Recruitment for the Technological Service of North Central Provincial Public** **Service (Open) North Central Province**

Applications are invited from eligible applicants for filling the following vacancies of North Central Provincial Public Service. Last date of calling application is 2025 .10.25 and the Competitive examination for the recruitment is to be held on November 2025 at Anuradhapura.

02. As per the Cabinet Decision No. 25/1421/802/004-VIII dated 11.08.2025, North Central Provincial Public Service Commission has the power to decide the number of recruitments.

03. Qualifications for the recruitments:

3.1 General Qualifications

3.1.1 Applicant must be a citizen of Sri Lanka

3.1.2. Every applicant must be physically and mentally fit to serve the duties of the post in any part of the North Central Province and must have an excellent character

3.1.3. Age must be more than 18 years and less than 35 years as at the date of closing date for applications

3.1.4. Applicant must confirm that the permanent resident within the limit of North Central Province not less than 03 consecutive years preceding the closing date of application.(It must be confirm through the Grama Niladhari Certificate form DS.4 at the Interview. Spouse's residence also considered

3.2. Technical Officer Grade III - (Civil, Mechanical, Electrical, Quantity Surveyor, Draughtsman)

(a) Educational Qualifications :-

- Have passed three subjects at G.C.E. (A/L) in the stream of Science / Mathematic Technology including Applied Mathematics / Pure Mathematics / Combine Mathematics and Physical Science / Engineering Technology in one attempt.
and
- Have passed six subjects at G.C.E. (O/L) with Credit passes for Language (Sinhala / Tamil / English) and any other subject in one attempt.

(b) Professional Qualifications

1. Technical Officer III, (Civil, Mechanical, Electrical, Quantity Surveyor, Draughtsman)

I. National . Diploma in Technology of Moratuwa University or Hardy Advance Technological Institute

or

II. Diploma in Engineering Science of National Apprentice and Industrial Training Authority.

or

III. Higher National Diploma in Engineering of Ministry of Education and Higher Education.

or

IV. Diploma in Technology of Open University of Sri Lanka.

or

V. Successfully completion of part I of Engineering Examination held by Institute of Engineering Technology.

or

VI. Completion of proficiency in National Vocational Skills (NVQ) Level 06 relevant to the field.

or

VII. obtained any other proficiency equal to above Technologic Qualification recognized by Tertiary and Vocational Education Commission after inquiring the above mention Technology Institutions and Ministry of Education and Higher Education.

3.3. Training Grade – Civil (One Year Training)

(a) Educational Qualifications

Have passed Three subjects at G.C.E. (A/L) with two subjects relevant to the field in Science / Mathematics / Technology streams in one attempt.

And

Have passed six subjects at G.C.E. (O/L) with Credit passes for Language (Sinhala / Tamil / English) and any other subject in one attempt.

(b) Professional Qualifications

Applicant should one of following professional qualification with above educational qualifications

I. Having obtained a National Diploma in Technology after following a Course (Civil) relevant to the post recognized by Tertiary and Vocational Education Commission.

or

II. Having Obtained any other proficiency equal to above Technological (Civil) Qualifications recognized by Tertiary and Vocational Education Commission after inquiring the above mention Technology Institutions and Ministry of Education and Higher Education

04. Method of recruitment :

4.1.1. Requirement will be based on the result of a Competitive examination and Interview in recruiting Grade III officers of Sri Lanka Technological Service. Qualified candidates will be selected by interviewing equal numbers to be recruited as per the vacancies exist and the order of the merit of the result of the applicants who passed the written examination.

4.1.2. Only in recruiting Grade III of Technical Officer (Civil) , when there is no qualified applicant as mentioned above, the remain vacancies will be filled with the candidates who fulfilled the qualifications for Training Grade .Examination will be held in Sinhala, Tamil and English Medium and all questions papers should be answered in one medium.

4.1.3 When recruiting the vacancies order of the merits , if there are qualified candidates who obtained equal Marks and if there is a current requirement of filling vacancies , the Provincial Public Service has the power to decide for the selection of more from the candidates who obtained equal marks .

Here, the paper will consist of questions to check that the knowledge acquired by Civil Officer of building constructions and maintenance, construction of roads and water supply and Drainage.</p> <p>(b) For the post of Grade III of Technical Officers (Mechanical) of North Central Provincial Public Service Here, the paper will consist of the questions to check the knowledge acquired by the Mechanical Officer.</p> <p>(c) for the post of Grade III of Technical officers (Electrical) of North Central Provincial Public Service Here, the paper will consist of the questions to check the knowledge acquired by the Electrical Officer</p> <p>(d) For the post of Grade III , Technical Officers of Draughtsman of North Central provincial Public Service Here, the paper will consist of the questions to check the knowledge acquired by the Draft man.</p> <p>(e) For the post of Grade III , Technical Officers of (Quantity Surveyor) of North Central provincial Public Service Here, the paper will consist of the questions to check the knowledge acquired by the Quantity Surveyor.</p>

4.5. As per the order of merit of the total marks obtained by them ,candidates who score 40% or more in each of the above papers will be selected by conducting a general interview in a number equal to the number expected to be recruited,

4.6. The Candidates should bring Geometric instruments and other equipment required to answer the above technology question paper to the Examination hall.

4.7. The appointing authority will conduct the interview. No marks will be awarded for this test, only the qualifications will be checked. .

4.8. Recruitment to the Technical Officer (Civil) Grade III of the Sri Lanka Technological Service at the end of the one - year training period

4.8.1. Candidates enrolled to the training grade will be recruited to the Technical Officer Grade III of the Sri Lanka Technological Service after successfully completing the training period and submitting a certificate of passing the examination conducted by an institution designated **by the Secretary of the Commission.**

4.8.2. Apprentices who fail to pass the examination conducted at the end of training have the opportunity to extend their training period for a period not exceeding 06 months. Apprentices who fail the examination conducted again at the end of the extended period will be terminated from their service.

05. Monthly Salary Scale or the Allowance :

Salary entitled to the Grade III of Technical Service :

5.1. The monthly salary scale for the post of Grade III of the Schedule III in the Public Administration Circular No. 10 / 2025 dated 25.03.2025 is Rs. 52,250-800x10-1,190x11-1,320x10-1,350-Rs. 100,040/- (MN – 3 2025). In addition to the person hold this post is entitled to the any other allowances paid by time to time by the Government.

5.2. Applicants recruited to the Training Grade will be paid a monthly allowance during the training period as per Schedule VI of the above-mentioned Public Administration Circular No. 10/2025.

06. Service Conditions :

6.1. The post of Technical Officer, Technical Officer, Grade III of the North Central Provincial Public Technological Service is permanent and pensionable. (Subject to future policy decisions taken by the government regarding the pension system)

6.2. The appointment of Technical Officer, Grade III of the North Central Provincial Public Technological Service is subject to a probationary period of 03 years, and it should be fulfilled the provisions of the relevant circulars to confirm in Service before exceeding 03 years of attaching the post as per the Public Administration Circular 18/2020 and related circulars.

07. Medium of Exam :

This examination will be held in all three mediums, Sinhala, Tamil and English. It is not allowed to change the medium later.

08. Method of Application :

8.1. It should be prepared using both sides of an A4 (21X25 cm) size sheet, and the relevant information should be clearly entered, with heading numbers 01 to 3 on the first page, 4 to 6 on the second page and the rest on the third page.

8.2. Applications that do not comply with the specimen application form, are incomplete, do not comply with the qualifications as per number 03 above, are received after the due date, and applications for which the examination fee has not been paid before the due date will be rejected without any notice.

8.3. Photocopies of the application form will not be accepted. (It would be useful to keep a photocopy of the application form in your possession.) Admissions Cards of the Examinations will be sent to the applicants by the Secretary, Provincial Public Service Commission. Issuance of examination admissions cards shall not be considered as confirmation of your eligibility.

8.4. Examination Fees : A receipt (NC –100) obtained from any Divisional Secretariat in the North Central Province, paying a sum of Rs. 720/-, to the Revenue Head No. 13.02.2003 of the North Central Provincial Council and must be attached to relevant column so as not to detach. (It would be useful to keep a copy of receipt in your possession.) It should be noted that examination fees have been paid will not be refunded or transferred to any other examination upon any circumstances.

8.5. The applicant's signature on the application form must be attested by a Government Principal or / Commissioner for Oaths / Lawyer / Officer holding a permanent Staff post in the Police Service / Staff Officer holding a permanent post in the Public Service drawing a monthly salary of not less than Rs. 59,228/- to the date of 01.01.2025.

8.6. Applicants in the Public Service or Provincial Public Service should submit their applications through the Head of Department.

8.7. Duly completed applications should be sent by registered post to the address “ Secretary, Provincial Public Service Commission, District Secretariat Premises, North Central Province, Anuradhapura ” before 2025.10.28 On the top left corner of the envelope in which the application sent should be written clearly as “ Recruitment for the post of of North Central Province Sri Lanka Technical Service of Sri Lanka - 2025 ”.

8.8. No complaints regarding loss or delay in posting of an application will be entertained.

9. Sitting for the examination :

9.1 Admission will be send by the Provincial Public Service Commission at least one week before the examination. It shall not be allowed to appear for the examination without an admission. Candidates appearing to the examination shall submit their admission with attested signature to the Invigilator. Candidates who have not received admission should inquire the Provincial Public Service Commission. It will be more effective to inform the Provincial Public Service Commission. it will be more effective that inquire the Public Service Commission with the application form and the receipt registered and certified copy of the NC 100 receipt for the application fee. One of the following documents can be presented to the invigilator to verify the identity of the candidate at the examination.

1. National Identity Card issued by the Department of Registration of Persons
2. Valid Passport
3. Valid Driving License

9.2. If it is revealed that a candidate is not eligible to appear for this examination, his candidature may be cancelled during the examination or after the examination or at any time after recruitment, if any information submitted by a candidate is found to be false, he may be dismissed from service. The Provincial Public Service Commission will notify the date of the examination in due course. All candidates are bound to act in accordance with the general examination rules and regulations.

9.3. The issuance of an admission card to appear for the examination shall not be deemed to be an admission that the applicant has fulfilled the qualifications for the post. The candidate is subject to the rules and regulations of the Provincial Public Service Commission regarding the conduct of the examination. If such rules are violated, they will be liable to a penalty imposed by the Provincial Public Service Commission.

9.4 The North Central Provincial Public Service Commission also has the power to fill of all the vacancies for these posts or not to fill of part or all of the vacancies, and to take decisions , if any matter which is not covered in the advertisement. Furthermore, in the event of any inconsistency between texts, the Sinhala language text shall prevail.
