Study at a High Ranked International University with a Government Scholarship – A Prestigious Offer for A/L Achievers!



In line with the Government's policy framework "A Thriving Nation – A Beautiful Life," the Ministry of Education, Higher Education and Vocational Education proudly launches an exclusive foreign scholarship program designed to empower 200 high-achieving G.C.E. Advanced Level students to pursue Bachelor's degrees at prestigious, internationally ranked universities abroad.

Under this program, designed to nurture "A Civilized Citizen – An Advanced Human Resource," the Ministry will offer government-funded scholarship opportunities to approximately 25 to 50 students in its inaugural phase for the 2026 academic year. The number of recipients will be progressively increased on an annual basis, with the objective of awarding a total of 200 scholarships over the five-year period from 2025-2029.

1. Call for Applications:

- I. Applications are invited from students who have obtained excellent results at the G.C.E. Advanced Level Examination 2024.
- II. Students from all academic fields are eligible to apply. However, priority will be given to the applicants willing to pursue studies in globally emerging fields or for fields that are not currently offered in Sri Lankan State Universities, specially those with potential to contribute to the economic growth and sustainable development of the country. - III. Prospective candidates are encouraged to select an international university and a degree program of their choice, provided the university is ranked within the top 500 in one of the global university rankings listed below.

Identify your preferred degree program

- •Choose a field of study that aligns with your academic and professional interests.
- •This program should be commenced in 2026.
- •Check the eligibility criteria and entrance exam requirements (if any).

Select the university ranked within the top 500 globally

•Find an international university that offers your chosen degree and is listed in the top 500 of recognized global university ranking.

Create an Login Account on the Ministry's Online Application Portal. https://foreignscholarships.mohe.gov.lk

Complete the online application form

• Fill in all required details accurately and upload the necessary supporting documents. Ensure that your application is successfully submitted. You should receive a confirmation message upon successful submission.

Ensure exclusive online submission

- Only applications submitted via the portal will be accepted.
- Hard copies sent by post will not be considered.

Submit the application before the deadline

• All applications must be submitted on or before 15th September 2025 to this Ministry. (Due to significant demand and heavy website usage, candidates should apply early to avoid last-minute issues)

Shortlisting by the Ministry

• The Ministry will evaluate applications and shortlist candidates based on eligibility and Academic merit (special consideration will be given to the All Island and District Merit criteria).

Attend a structured interview (if shortlisted) Shortlisted candidates will be called for a structured interview by the Ministry at short notice to assess the eleigibility to award the scholarship grant. 8. Check your selection status to confirm eligibility for the grant 9. Apply to the selected foreign university Students selected through the strucrured interview will be advised to apply to their choosen international university. 10. 3. General Eligibility Requirements:

Applicants are required to fulfill all the general eligibility criteria mentioned below.

- I. Should be a citizen of Sri Lanka.
- II. The applicant should have a minimum mark of 30% for the Common General paper at G.C.E A/L examination -2024, conducted by the Department of Examinations of Sri Lanka.
- III. Should possess a good knowledge of English (Minimum "C" Grade for General English at G.C.E A/L examination or equivalent).
- IV. Should be in good health and ready to live overseas (relevant country) during the period of study.

4. Scope of Award:

The award encompasses the following components, applicable for a maximum duration of four years:

- I. Tuition and other academic fees
- II. Monthly stipend to assist with food and accommodation expenses
- III. Contribution for health insurance
- IV. One-time economy class round-trip airfare, including local transportation from the nearest airport to the host university

The overall value of the award package for a year shall be subject to a ceiling of Rs. 20,000,000 (Twenty Million Rupees). However, the grant amount allocated to each student will be determined by the Ministry, taking into account the candidate's academic merit and chosen field of study. Priority will be accorded to those pursuing globally emerging disciplines, particularly fields with substantial potential to contribute to the country's economic growth and sustainable development.

5. Terms and Conditions:

- I. This scheme will provide financial support to pursue the Bachelor's degrees only.
- II. Candidates must return to Sri Lanka after completing the first degree.
- III. This scheme provides financial support up to a maximum of 4 academic years.
- IV. Candidates are strongly encouraged to choose foreign universities that are recognized by the University Grants Commission (UGC), Sri Lanka. Please refer to the UGC web site (https://www.ugc.ac.lk/)
- V. Candidates are advised to select the degree programs that are recognized by the Professional Bodies of Sri Lanka. (Please refer to Annexure 2)
- VI. Candidates awarded with this scholarship would not be considered for university admission process of UGC, Sri Lanka.
- VII. Candidates are required to sign a Bond Agreement with this Ministry, providing their formal consent to return to Sri Lanka upon completion of the studies and contribute to the economic growth and sustainable development of the country.
- VIII. Scholarship will cover only the prescribed duration of the selected degree program and will not be extended beyond that period.
 - IX. Any candidate who declines to accept the scholarship offer after the completion of the selection process will be rendered ineligible for consideration in any future scholarship opportunities administered by this Ministry.

- X. Any form of canvassing whether written or verbal will be considered as a disqualification for a scholarship.
- XI. Providing any false or misleading information in the application may result in disqualification at any stage of the process and could lead to the revocation of the award and the requirement to repay the grant.

Guidelines for submitting the online application

Applicants are advised to carefully read the following guidelines before submitting their online application. Failure to comply with these instructions may result in the rejection of your application.

Preparation of Login Account

Provide a valid email address. If you do not have an email account, please create one before proceeding.

Required Documents for the Online Application

Prepare the following documents before filling out the online application form. All documents must be clear, readable scanned copies in PDF format with a maximum file size of 2 MB each.

- I. 2024 G.C.E. Advanced Level Result Sheet Upload a scanned copy of your 2024 G.C.E. A/L result sheet.
- II. **Proof of English Proficiency** Upload a scanned copy of your highest English proficiency certificate/result sheet.
- III. **Justification for Selecting the University** Submit a written statement, not exceeding 300 words, outlining your reasons for selecting the university of your choice. The document should be saved and uploaded in PDF format.
- IV. Statement on Contribution to National Development Submit a written statement (maximum 300 words) on how you intend to contribute to the economic growth and sustainable development of Sri Lanka upon completion of your studies. Save and upload the document in PDF format.

Special Notices

- I. All future communications regarding this program will be sent to the email address you provide.
- II. You are required to regularly check your email inbox (including the spam/junk folder) to ensure you do not miss important updates.
- III. Provide a valid telephone number for ease of communication. While the primary mode of communication will be email, you may be contacted by telephone if necessary.
- IV. Ensure that your application is successfully submitted. You should receive a confirmation message upon submission.
