INFORMATION SECURITY ENGINEER - DATA CLASSIFICATION AND LEAKAGE PREVENTION

The Information Security Engineer - Data Classification and Leakage Prevention is responsible for designing, implementing, and maintaining data classification and data loss prevention (DLP) strategies to safeguard sensitive information. This role ensures compliance with regulatory requirements, mitigates data leakage risks, and supports the organization's information security objectives.

RESPONSIBILITIES

- Maintain and update data classification policies and frameworks to categorize data based on sensitivity and criticality.
- Manage and maintain tools and processes for automated data classification and tagging.
- Configuring DLP policies, rules, and exceptions based on data classification guidelines and regulatory requirements. This involves enabling controls for data in motion, data in use, and data at rest.
- Managing DLP infrastructure and software updates to ensure optimal performance.
- Monitoring DLP dashboards, alerts, and reports to identify potential data leakage incidents and policy violations.
- Conduct regular assessments to identify and address vulnerabilities in data protection controls.
- Educating employees on Data Classification / DLP policies and procedures through engaging training and awareness campaigns.
- Work with IT, legal, and compliance teams to integrate DLP solutions with existing systems.
- Continuously research and evaluate emerging security threats and trends, recommending and implementing appropriate security controls.
- Working with PAM solution is added advantage.

ELIGIBILITY CRITERIA

- Candidate should be a citizen of Sri Lanka.
- Possess a Bachelor's degree or Master's degree in Information Security / Information Technology by a degree awarding university or an institute recognized by the University Grants Commission of Sri Lanka.
- Minimum 2 years of experience in information security, with a focus on data classification, DLP, or related areas.
- Hands-on experience with DLP tools (e.g. Symantec, GTB, Forcepoint, Microsoft Purview) and data classification platforms.
- Strong understanding of data protection regulations and frameworks (e.g., PDPA, ISO 27001).
- Sound knowledge on understanding of industry trends, emerging technologies & threats and specific threats targeting financial institutions.
- Possess excellent analytical and problem solving skills
